- On September 12, 2023, 26,177 Issuer shares were distributed from a GRAT dated September 9, 2022 ("GRAT #3") to Mr. Sanchez and then contributed to GRAT #4. Mr. Sanchez is the sole settlor, trustee and annuitant of GRAT #3 and GRAT #4.
- On September 12, 2023, 11,292 Issuer shares were distributed from a GRAT dated August 25, 2021 ("GRAT #2") to Mr. Sanchez and then contributed to GRAT #4. Mr. Sanchez was the sole settlor, trustee, and annuitant of GRAT #2 and GRAT #4. GRAT #2 has terminated.
- Represents shares held in a trust regarding which Mr. Sanchez's spouse is the trustee and Mr. Sanchez's child is the beneficiary.
