Mahala Johnson, director of product management, will moderate a session titled, "Operational Impact of Faster Disbursements," in the Crystal D-F room from 8:00 a.m. – 8:50 a.m. Wednesday, May 8.

Using case studies from early movers in faster payments, this session will spotlight how organizations can launch faster payments from an operational standpoint. Although a majority of organizations expect faster payments to save them money, launching it can be tough for the operations team. Additional speakers include Eric Froust, senior director, Product Management, Early Warning, Steve Everett, director, PayPal and Keith Gray, vice president, The Clearing House.
